## 2. Review of the course

### ◆General review

- We were supposed to have six people applied for Skill Assessor Certificate (SAC), however one of them didn't have enough experience to apply for SAC. Therefore he participated as an assessor, could not apply for SAC this time. The five assessors applied for SAC.
- Nine people participated in Skill Evaluation Trial (SET) as examinees. 8 of them were students.
- It would be ideal, if we could have used tools and materials which could be sourced locally in Vietnam. However there are not enough suitable tools and material available locally, as this was the first time to implement Information Network Cabling 2nd Grade Skill Evaluation Trial/ skill test in Vietnam. So we sent almost all the tools and materials for SET from Japan.
- All the participants were very positive about the skill test. They didn't hesitate to ask questions whenever they could not understand. This attitude helped the whole procedure to go on very smoothly.
- We did the assessor interview on a one-to-one basis on the final day of the SAC, discussed about the current states of Information Networking Cabling and how they source tools and materials in Vietnam.
- Information Networking Cabling 2nd grade seemed to be suitable for active skilled workers. As an evidence, one of the two successful examinee was a working as a skilled worker.
- All the assessors did well generally. However, they didn't do the allocation of roles in the team thoroughly. They must do a assessor team meeting properly, and all of them had to attend. They had to have a record-keeper to take notes and keep records.

### ◆Future plans

- Even if the examinee were given the best tools, if they did not know how to look after the tools properly, it will be no use.
- They should use locally sourced tools and materials for the skill test.

- Japanese skill tests are designed to meet international standards. We hope that one day Vietnam will create their original skill test which reflects its national demand and condition. However the quality and standard should be maintained and must be the same as international standards.
- Assessors always must be objective, fair, and strict whenever they evaluate examinees. This will lead to establish authoritative skill test.
