2. Review of the course

Skills Assessor Training consists of lecture, practical training and role play. I gave guidance to the participants so that they could be assistant assessors after the course. Also, they experienced assessors in the subsequent trial skills test. By the course above experiencing rules and manners of both examinee and assessors, they were able to finish all the jobs on the trial on time from preparation to scoring & evaluation following the regulations.

There were 19 examinees for the trial skills test. The results of the practical exam indicate the possibilities that some examinees did not practice basic training enough. Also, the results of the theoretical exam indicate that most of the examinees possibly lacked preparation for the exam.

As for the theoretical exam, I suggest that it would be great to know the range of studies if a guidebook was available for self-study.
