2. Review of the course

- This time, we cultivated six assessors. (Four of them have taken Skills Assessor Training in FY 2017. Two new assessors have been added this time.) All the assessors were very eager to learn and the course was very successful. The two new assessors were highly competent and they caught up with lectures.
- On the preparation of the venue, we have noticed the remarkable improvement on maintenance of equipment and consideration of safety.
- Sequence control exam contents are not open to the public. Confidentiality of its skills tests affects to the principle of fairness more than the other job trades. I have taught the assessors not only the compliance on the management of skills

test but also the mindset as an assessor and deepened their understandings of its importance.

- 10 people took the exam on Skills Evaluation Trial and only one person passed. This successful examinee was from a company which had sent its employees to SET last year. I could figure out that this examinee had prepared and practiced for SET enough. It is necessary to study and practice for exams in advance. Also, improving the awareness ratio of the skills test is an urgent issue. In order to resolve that, I think improving the way of announcements of the skills tests and effectively publicize to recruit potential examinees through colleges and Japanese companies are necessary.
