2. Review of the course

General review

- SET this time was operated by skills assessors composed of eight people. Seven of them were certified skills assessors, and one of them has completed Skills Assessor Training course and it was his second time to administer SET. It was smoothly carried out without any problems for 4 days with their experiences, and they proved that they can perfectly conduct/ operate the trial by themselves in the future.
- As issues in the future, maintenance of turning machine, and training method to increase the pass ratio of the examinees are considered.
For the maintenance of turning machine, in the training this time, one of the examinee was forced to use a spare turning machine due to defect in the electrical systems. In addition, another examinee had to use a turning machine

having problems on spindle run-out that has not been resolved, so it was likely to occur during the trial at any time. It is mandatory that increasing the awareness of facility personnel and take countermeasures not to absolutely occur any defects like these when preparing for the trial.

On the other hand, in terms of increasing the pass ratio, it can be said that taking place exam preparation course for examinees and thoroughly train them based on the standard work manual is the only way.

- In Japan, we have the history of conducting countermeasure training course for skills test at a lot of vocational training facilities during 1965 to 1984. With the training course, how to create standard work manual and processing methods based on it were thoroughly carried out.
- VTC (Vietnam Cable Television) interviewed us for our project, Skills Evaluation Trial (SET), from 11:00AM-12:00PM on September 12th. They would like to interview about the skills test conducted onsite with JICA's recommendation. In the interview, the questions from the Director were:
 - how have the assessors, examinees and equipment improved through SET?
 - what is the level currently they are?
