## 2. Review of the course

I did the certification of skills assessors on the Skills Assessor Certification by implementing the Skills Evaluation Trial. This time, the skills assessors for the trial were 9 and 3 assessors out of 9 were eligible for the certification. Most of them were experienced assessors so the trial was completed successfully with both the theoretical and the practical exams.

The subject assessors performed all the tasks according to the rules in the preparation, the implementation, the scoring & evaluation and also did the improvement of the problems and achieved good results. They will be expected to actively perform in the future projects.

With the skills test, the results of the examinees were good in both the theoretical and the practical exams. In particular, it was excellent in the theoretical exam, and skill training and practice affected to the results very much. In the future, it will be better to understand the skills and technical meaning of each assignment of the practical exam, and work on practical training and practice, and also study on the theoretical exams.
